A new Board has been assembled to reflect the scale, ambition and responsibilities of the expanded Low Carbon Hub IPS. The Chair believes that to maintain a professional board, the Non-Executive Directors should be paid. This is set out in more detail in the Chair's letter.

Rule 17.11 states that the society can pay its directors, but only if the members approve the basis for the payments. Members are therefore asked to approve the principle of Non-Executive Directors receiving payment in compensation and recognition of the time and commitment required to be active members of the Board. Remuneration is being proposed on the following basis:

- The initial rate should be £5,000 per annum as a material amount that would ensure Board member attendance and focus.
- That the Chair should receive between 1.5 and 2.5 times the rate for other Non-Executive Directors, at discretion of the Board. This is to allow some responsiveness to candidate quality and the needs of the organisation at any particular time.
- That this rate will be reviewed annually, and may be increased in line with any salary increase agreed for Low Carbon Hub staff.
